Whereas, the Indian Metrological Department has warned about the possible impact of the 'NIVAR' Cyclone along the coastline of Tamilnadu and Puducherry, the Puducherry region is expected to be severely impacted by the Cyclone and that there is a grave danger to life, health or safety of the public.

Whereas the undersigned is fully satisfied that there are sufficient grounds for passing prohibitory orders under section 144 of Criminal Procedure Code, 1973 to prevent loss of life and ensure the safety of general public.


Now Therefore I, Purva Garg, I.A.S, District Magistrate, Puducherry in exercise of the powers conferred upon me under section 144 of the Criminal Procedure Code, 1973, with a view to prevent danger to human life and safety do hereby **prohibit the presence or movement of one or more persons in public places in the entire Puducherry region and closure of all shops and establishments from 24-11-2020 9.00 PM to 26-11-2020 6.00 AM, subject to further revision.**

The emergent nature of case and circumstances do not permit serving of notice to the concerned in due time and hence this order is passed exparte U/S 144 (2) of Criminal Procedure Code, 1973.

This order shall not apply to agencies / officials of the Government involved in the enforcement of Law and Order and Cyclone duty. Maintenance of essential services like Milk-Ponlait Booth, Fuel Bunk, Pharmacies and Health services are allowed to continue.
