ORDER

WHEREAS, the Department of Fisheries and Fishermen Welfare has proposed to establish Diesel / Kerosene outlet in the Mahe Fishing Harbour premises through State Fishermen Co-operative Federation Limited to cater the needs of the Fishermen.

2. AND WHEREAS, the Deputy Collector (Revenue) Mahe has identified the Government land situated at R.S.No.142 of Mahe Revenue Village and furnished a proposal for transfer of land to the Department of Fisheries and Fishermen Welfare.

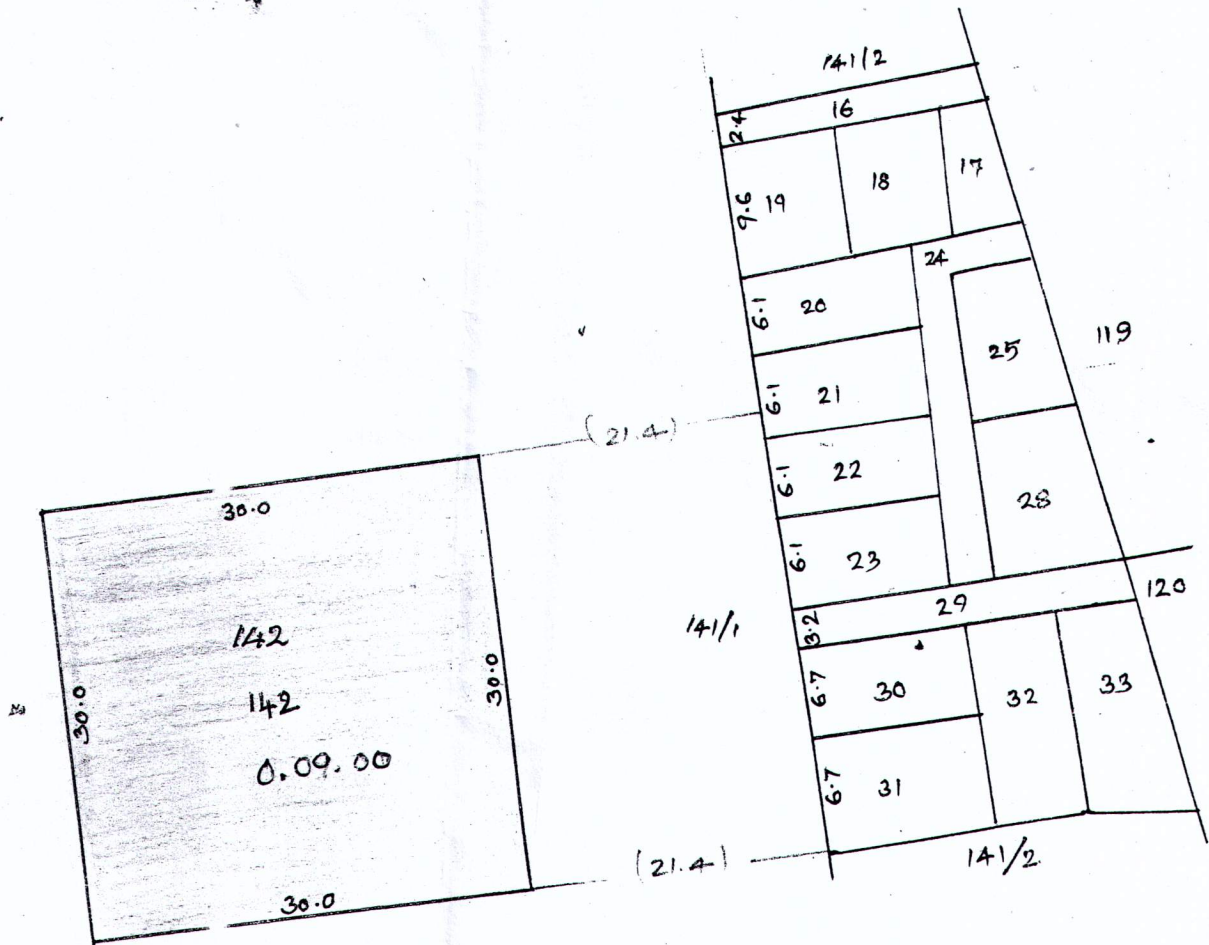
