Personal Interview for selection of Village Level Entrepreneurs (VLE) for establishment of Common Service Centres (CSC) in Puducherry and Oulgaret Municipal limits was held on 09th and 10th of October 2017 in the Chamber of the District Collector -cum- Chairman (PDeGS), Puducherry.


2. As per the Guidelines for implementation of "Common Services Centre 2.0 - A way forward" under Digital India Programme, wide publicity was given in leading newspaper and official websites www.py.gov.in and <https://collectorate.py.gov.in>, inviting applications from the interested volunteers to establish CSCs in 26 wards at Puducherry and Oulgaret Municipal limits. In response to this Office notification, 73 applications were received for the establishment of CSC in various wards of Puducherry and Oulgaret Municipal limits. Out of the 73 applications, 27 applicants preferred Puducherry Municipality and 46 applicants preferred Oulgaret Municipality. All the 73 applicants were informed through Speed Post and email to attend the Certificate Verification and Personal Interview on the dates allotted to them.

3. In Puducherry Municipality, out of 27 applicants, 23 applicants have appeared for the interview and the remaining 04 (four) applicants did not turn up. In Oulgaret Municipality out of 46 applicants, 35 applicants have appeared for the interview and the remaining 11 applicants did not turn up. Few of the applicants have not produced Nativity Certificates due to non availability of sufficient time. However, they were also considered for scrutiny and personal interview.

4. Each applicant was screened by the Committee Members and selection has been made based on their performance in the personal interview. The shortlisted list of the Village Level Entrepreneurs for setting up of CSCs in the wards of Puducherry and Oulgaret Municipal limits is enclosed as Annexure. In Puducherry Municipality (04) four wards (i.e.) VOC Nagar, Goubert Nagar, Thirumudi Nagar & Kurusukuppam and in Oulgaret Municipality (02) two wards (i.e.) Alankuppam and Periyakalpet (East) wards were not preferred by any applicant and are remaining vacant. Further, the selection shall be provisional subject to the production of Nativity Certificate and their ability to establish CSC within one month in the ward allotted to them, failing which the allotment will be cancelled and no requests thereto shall be considered.
